1. SEPTTEL SENT EVENING JUNE 9 DESCRIBED PLIGHT OF TWO  
AMCIT NUNS REPORTED TO BE TRAPPED IN RWANDA WITH GROUPS  
OF THEIR FELLOW NUNS OF THE SAME ORDER. SEPTTEL REPORTED  
THAT AMCIT SISTER [REDACTED] WAS TRAPPED  
IN KIBUYE, RWANDA WITH A GROUP OF 23 OTHER NUNS, AND  
AMCIT SISTER [REDACTED] WAS TRAPPED IN KIRUHURA WITH  
A GROUP OF 14 OTHER NUNS.

JUNE 9 FROM SISTER NANCY CHARLESWORTH, OF SISTERS OF ST. MARY OFFICE IN KENMORE, NEW YORK. SISTER NANCY REPORTED THAT SISTER [REDACTED] WAS NOT, IN FACT, PERSONALLY TRAPPED IN RWANDA, BUT IS ABLE TO TRAVEL BACK AND FORTH BETWEEN KIBUYE AND GOMA, ZAIRE. SISTER [REDACTED] WAS SPENDING NIGHT OF JUNE 9 IN GOMA. AF/C DESK OFFICER URGED SISTER NANCY TO ORDER SISTER [REDACTED] NOT TO RETURN TO RWANDA, BUT SHE REFUSED, SAYING THAT SISTER [REDACTED] HAD TO RETURN TO RWANDA AND WOULD NOT LEAVE PERMANENTLY UNLESS THE WHOLE GROUP OF NUNS COULD
