#### SITERP COVERING PERIOD 150600B MAY TO 151800B MAY 94.

- 1. GIN SITUATION. GEN SITUATION IS TENSE, EXCHANGE OF ARTY/MOR AND SA FIRING BETWEEN RPP AND RGF CONTINUED THROUGHOUT OUT THE DAY AT VARIOUS PLACES IN KIGALI CITY. THE MAJOR BATTLE AREA WAS KICHIKIRO, REMERA AND REBERO AREA. FIGHTING BETWEEN RPF AND RGF REPORTED FROM CYERU/NKUMBA IN THE NORTH AND BUGBSERA IN THE SOUTH, NO CHANGE IN THE POSITIONS BEING HELD BY BOTH THE FACTIONS IN CITY. MILITIA STILL HOLDING SOME AREAS IN KIGALI CITY UNDER THEIR CONTROL.
- 2. POLITICAL ACTIVITIES. NTR.

WHILE COMING BACK THE TEAM WAS FIRED UPON FROM KADDAFI CROSSING BY RPF. THE CONVOY WAS HALTED FOR ABOUT 45 MINS. THE SAME FIRING INCIDENT TOOK PLACE AT THE SAME SPOT WHILE TEAM WAS PROCEEDING TO GITARAMA. IT SEEMS RPF INTENTIONALLY FIRED ON THE CONVOY. FIVE CANADIAN OFFICERS INCLUDING TWO JOURNALISTS PROM CTV HAVE ARRIVED UNAMIR FORCE HO.
