- GEN SITUATION. THE DAY WAS OBSERVED TO BE TENSE, HEAVY EXCHANGE OF ARTY/MORTAR, HMG AND SAB FIRE CONTINUED BETWEEN THE WARRING FACTIONS THROUGHOUT THE DAY IN KIGALI. FIGHTING WAS ALSO REPORTED IN GISOZI, NYAMIRAMBO AND IN THE CITY CENTRE. BOTH SIDES ARE NOT SHOWING ANY SIGNS OF ABATING THE WAR. THERE WERE NO MAJOR CHANGES IN THE DISPOSITIONS OF THE WARRING FACTIONS IN THE CITY THE NORTH IN THE COUNTRY. AND IN SOUTH AND. CIVILIANS/MILITIA AND THE GENDARMES WERE OBSERVED TO BE MANNING ROAD BLOCKS AND CHECK POINTS IN RGF CONTROLLED AREAS. FC ARRIVED IN NAIROBI VIA ENTEBBE IN THE AFTERNOON. THE THIRD TRIPARTITE CEASE FIRE MEETING CONTINUED THIS AFTERNOON PROM 1400 TO 1700 HRS, UNDER THE CHAIRMANGHIP OF THE DFC. SOME PROGRESS WAS MADE ON THE DISCUSSION OF THE CEASE FIRE DOCUMENT. THE ISSUE OF THE TRANSFER OF DISPLACED PERSONS WAS ALSO DISCUSSED AT LENGTH. THE NEXT MEETING IS SCHEDULED FOR ON 11 JUNE 1994. THE HQ BUILDING RECEIVED A DIRECT HIT FROM AN RPG ROUND FIRED FROM THE DIRECTION of north west causing damage to the building. There were no CASUALTIES. A STROW PROTEST WILL BE LODGED TO BOTH PARTIES TOMORROW.
- 2. POLITICAL ACTIVITIES: IT WAS REPORTED THAT THE RPF AND THE INTERIM GOVT SENT DELEGATES TO THE CAU MINISTERIAL SUMMIT IN TUNIS BUT THE RPF DELEGATION WAS NOT ALLOWED TO ATTEND THE PROCEEDINGS, THE RPF HAS SINCE CONDEMNED THIS ACTION OF THE OAU. THE VATICAN HAS CALLED ON BOTH SIDES TO STOP THE CARNAGE AFTER THE KILLING OF THE ARCHBISHOP OF KIGALI AND 12 OTHER CLERGYMEN BY THE RPF SOME TWO DAYS AGO.

3. YACTIONAL ACTIVITIES.

- A. RPF. RPF CONTINUED THE HEAVY SHELLING OF RGF POSITIONS IN KYCHIRU AND KIMIHURURA THROUGHOUT THE DAY. HEAVY FIGHTING WAS ALSO REPORTED AROUND GISOZI AND GATSATA AND NYAMIRAMBO. REBERO HILLS IS NOW FIRMLY UNDER RPF CONTROL. CONSOLIDATION AND REINFORCEMENT OF CAPTURED GROUND CONTINUED AROUND KABGAYE, RUHUNGO AND NYANZA.
- B. RGF. RGF CONTINUE TO FIGHT BACK FROM THEIR POSITIONS IN NYAMIRAMBO, KYCHIKIRU AND KIMIHURURA. EXCHANGED HEAVY ARTY/MORTAR AND HMG FIRE IN GISOZI AND GATSATA NORTH OF KIGALI CITY. CONTINUED TO CONSOLIDATE AND REINFORCE THEIR POSITIONS AROUND GITARAMA IN THE SOUTH AND RUHBNGERI.
- C. MILITIA. STILL MANNING SOME CHECK POINTS IN RGF CONTROLLED AREAS IN THE CITY.

4. ONN MILITARY ACTIVITIES

A. FORCE HO. NORMAL ROUTINE WORKS WERE CONDUCTED. STAFF ERIEF WAS CONDUCTED BY THE DFC AT 0730 HRS. FC ARRIVED NAIROBI THIS AFTERNOON AND HELD A MEETING WITH THE CIVILIAN

STAFF IN NAIROBI. THE DFC CHAIRED THE TRIPARTITE CHASE FIRE TALKS FOR THE SECOND DAY AT THE FORCE HQ. THE DISCUSSIONS OF THE CHASE FIRE DOCUMENT COMMENCED APTER A LONG DISCUSSION ON THE MOVEMENT OF DISPLACED PERSONS TO SAFER AREAS.

- B. UNCAUR. AREA OF OPERATION IS CALM. ROUTINE PATROL NERE CARRIED OUT IN AOR. ACMO RETURNED TO KABALE WITH THE DFC ON 081300 HRS. DFC ADDRESSED ALL AVAILABLE OFFICERS AT UNOMUR HO BEFORE LEAVING FOR KIGALI. 15 VEHICLES BELONGING TO DIFFERENT HUMANITARIAN RELIEF AGENCIES CROSSED THE BORDER THROUGH KATUNA TO RWANDA WITH HUMANITARIAN RELIEF ITEMS. A TOTAL OF 36 VEHICLES CROSSED THE BORDER AT KATUNA, KASHEKYE, KYANIKA AND MERAMA HILLS TO RWANDA WITH 197 PASSENGERS INCLUDING 41 REFUGEES. 46 VEHICLES CROSSED INTO UGANDA WITH 245 PASSENGERS. APPROXIMATELY 900 RWANDESE CROSSED THE BORDER AT KYANIKA TO WORK AND MARKETING AND RETURNED THE SAME DAY. TWO HELICOPTERS ARE PRESENTLY OPERATIONAL.
- C. BYURAT. CONTINUED TO PROVIDE SECURITY AT KIA, AMAHORO STADIUM AND FORCE HQ. PROVIDED PROTECTION AND HUMANITARIAN ASSISTANCE TO DISPLACED PEOPLE AT KIA AND AMAHORO STADIUM. PROVIDED ESCORTS FOR HUMANITARIAN ACTIVITIES AND OTHER DUTIES DURING THE PERIOD.
- D. TUN PLATOON (+). AREA OF OPERATION RELATIVELY CALM. PROVIDED SECURITY AND HUMANITARIAN ASSISTANCE TO DISPLACED PERSONS AT MILLE COLLINS HOTEL, MERIDIEN HOTEL AND KING FAISAL HOSPITAL. ALSO CARRIED OUT ESCORT DUTIES WITH APCS.
- F. MILOR PROVIDED LIAISON AND ESCORTS TEAMS DURING THE PERIOD. THE CMO MET ALL THE COUNTRY SENIORS AND BRIEFED THEM ON THE UNMO DEPLOYMENT FOR PHASE 1.
- 5. UNCIPPOL. 15 ARE STILL IN NAIROBI.
- ENHANTIARIAM ACTIVITIES. AHT VISITED KING PAISAL HOSPITAL, AMAHORO STADIUM AND REFUGES CAMP AT KIA TO EVALUATE THE PRESENT MEDICAL SITUATION. AHT AND MSF MET WITH ICRC TO COORDINATE THEIR ACTIVITIES. ONE AMESTHETIST FROM MSF JOINED THE ICRC TEAM. ICRC ESTABLISHED A REFUGER CAMP AT NYARUSHASHI NEAR CYANGUGU. CONVOY OF ICRC ARRIVED IN BAKUKUVA TO DISTRIBUTE FOOD IN CYANGUGU PREFECTURE TOMORROW. SOME MORE WOUNDED PERSONS FROM KABGAYE HOSPITAL WERE EVACUATED TO NYANZA. HAC HELD A MEETING TO DISCUSS THE SECURITY AT ST ANDRE ORPHANAGE. THE EVACUATION OF DISPLACED PERSONS EXERCISE REMAINS SUSPENDED DUE TO SECURITY REASONS, ICRC TREATED 30 PATIENTS IN THEIR HOSPITAL DURING THE PERIOD AND DELIVERED 116 TONS OF FOOD TO 9000 PERSONS IN MANYAGIRO CAMP IN THE GENERAL AREA OF CYUMBA. THEY ALSO DELIVERED 75 TONS OF FOOD TO DISPLACED PERSONS AT RUTARE. THE ICRC ALSO VISITED AND PROVIDED MEDICAL ASSISTANCE AT CAMPS IN KABGAYE AND KORA.
