2. ON JULY 24 CHARGE WAS INFORMED BY COL. GAHIMA, RPF EXECUTIVE COMMITTEE MEMBER, THAT RPF CHAIRMAN KANYARENGWE WOULD NOT/NOT BE ABLE TO MEET WITH HER AS PLANNED ON JULY 25, BUT HOPED TO BE IN KAMPALA "TOWARDS THE END OF NEXT WEEK" (THE WEEK OF JULY 27) AND WOULD LIKE TO MEET WITH HER THEN. CHARGE SAID SHE WOULD BE HAPPY TO MEET WITH KANYARENGWE WHENEVER HE WAS IN TOWN. (GAHIMA SAID KANYARENGWE IS PRESENTLY IN RWANDA.)

3. GAHIMA SAID THAT DR. THEOGEN RUDASINGWA, WHO WAS

UNCLASSIFIED

A MEMBER OF THE RPF DELEGATION TO WASHINGTON, WOULD, HOWEVER, MEET WITH CHARGE TO GIVE HER A MESSAGE FROM KANYARENGWE. RUDASINGWA CALLED LATER; THE MEETING IS SET FOR 6:00 P.M. JULY 24. CHARGE WILL USE REFTEL TALKING POINTS WITH RUDASINGWA.

4. GAHIMA SAID NEITHER HE NOR "ANY OTHER OF THE BOYS" HAS A TELEPHONE, SO WAS UNABLE TO PROVIDE ANY WAY OF CONTACTING THEM. WE ARE THUS STILL DEPENDENT ON THEIR CALLING US. RUDASINGWA SAID THAT THEY WERE "WORKING ON THE PROBLEM" OF EASING COMMUNICATION.
