HE COMPLAINED OF FRENCH MILITARY INTERVENTION IN SUPPORT OF THE GOR, OF EFFORTS TO SUBVERT THE NEUTRALITY OF THE MILITARY OBSERVER GROUP, AND OF ESCALATION OF COMBAT BY THE FAR. HE CAREFULLY NOTED POINTS MADE BY CHARGE CALLING FOR CONTINUED RESTRAINT, AND PROMISED THAT THE RPF WOULD COMPLY. END SUMMARY

(REFTEL A). RPF REPRESENTATIVE DR. EMMANUEL NDAHIRO AND POLOFF ALSO ATTENDED THE 40-MINUTE MEETING AT THE CHARGE'S RESIDENCE.

RUDASINGWA EXPRESSED APPRECIATION FOR THE "FAIR HEARING" THAT THE RPF DELEGATION HAD RECEIVED IN WASHINGTON. HE CONTRASTED USG OBJECTIVITY WITH FRENCH AND BELGIAN INTERFERENCE ON BEHALF OF THE GOR. WITHOUT CITING DIRECT EVIDENCE, RUDASINGWA CHARGED THAT THE FRENCH WERE "DIRECTING THE GOVERNMENT CAMPAIGN," TRANSPORTING RWANDAN TROOPS, AND USING RWANDA AS A "TESTING GROUND FOR NEW WEAPONS." (HE REFERRED SPECIFICALLY TO A "NEW" 105 MM LONG RANGE ROCKET LAUNCHER.) HE COMPLAINED THAT THE NUMBER OF FRENCH TROOPS IN RWANDA WAS FAR GREATER THAN WHAT WAS CALLED FOR UNDER THE GOF-GOR BILATERAL AGREEMENT, AND SAID THAT THE RPF WOULD PROPOSE THAT IF THE FRENCH TROOPS WERE REALLY IN RWANDA TO PROTECT FRENCH CITIZENS, THAT ROLE SHOULD BE TAKEN OVER BY UN TROOPS.

RUDASINGWA COMPLAINED THAT THE RPF WAS NOT CONSULTED ABOUT BELGIUM'S OFFER TO FLY LAND ROVERS INTO KIGALI FOR THE GOMN, AND SAID THAT PRESIDENT HABYARIMANA SHOULD NOT BE SOLICITING HELP FOR THE GOMN, BUT SHOULD LEAVE IT TO THE OAU'S JOINT COMMISSION. RUDASINGWA REPEATED CHARGES THAT THE FAR WAS INITIATING AND ESCALATING ATTACKS ON THE RPF AND QUESTIONED PRESIDENT HABYARIMANA'S INTEREST IN ACHIEVING A CEASEFIRE. RUDASINGWA CLAIMED THAT THE RPF WANTED TO HONOR THE JULY 19 TRUCE, BUT WAS BEING FORCED TO REACT TO FAR ATTACKS.

6. CHARGE MADE THE POINTS CONTAINED IN REFTEL B, WHICH RUDASINGWA AND NDAHIRO TOOK CAREFUL NOTES ON. THEY PROMISED TO CONVEY THE MESSAGE TO THE RPF LEADERSHIP, WHICH THEY SAID WAS MEETING IN RWANDA. RUDASINGWA SAID THAT THE RPF "WILL CONTINUE TO EXERCISE RESTRAINT," BUT WOULD NOT DO SO FOR LONG "IN THE ABSENCE OF RESTRAINT ON THE OTHER SIDE." ACCORDING TO RUDASINGWA, RPF "CHIEF COORDINATOR" RUTAREMERA WILL HEAD THE RPF DELEGATION TO ADDIS ABABA. DESPITE THE INFORMATION IN

7. THE CHARGE ASKED RUDASINGWA IF HE HAD DETERMINED A WAY FOR THE EMBASSY TO CONTACT THE RPF. HE SAID HE HAD NOT, BUT THE RPF WAS STILL WORKING ON IT; HE REALIZED THE DIFFICULTY CREATED BY THIS, AND HOPED TO HAVE A CONFIDENTIAL
