- these issues in his letter of 19 January to the Council, pointed out that your main concern was about the attitude of RPF. He indicated that, if RPF ultimately accepted the French initiative, there may not be too many problems. However, if the RPF continue to oppose it, it was anticipated that difficulties would arise. Riza pointed out that you had already reported that the RPF attitude had become less friendly. He mentioned that the APCs transferred from Somalia had been held up at the Uganda-Rwanda border. He also pointed out that UNAMIR Headquarters were located in a zone held by RPF and that the latter controlled all access routes as well as the airport. He added that you had also prepared contingency plans for withdrawal, should that become necessary.
- 6. Members of the Council then proceeded to discuss the draft resolution paragraph by paragraph. A number of changes were made to the text, although they do not affect the basic substance of the proposed operation. A copy of the revised text of the resolution is attached. The revised text is largely agreed upon except for operative paragraphs 1 and 3 which will be the subject of further informal contacts between the French delegation and other concerned members of the Council.
- 7. The attached self-explanatory letter from RPF, dated 21
 June, was distributed during the consultations. At that point,
 the Perm. Rep. of New Zealand suggested that the Council should
 take a pause to consider this letter which, in his view, raised
 fundamental questions regarding the safety and security of UNAMIR
 personnel.

- 8. The Perm. Rep. of France replied that his Government was in contact with the RPF in Kampala, Kigali, Brussels and Paris. He also pointed out that other countries were working on the RPF to convince it to modify its views. He believed that the RPF was "quite far from having said its last word on the matter" and that there was still a possibility that it might reconsider its position. He then pressed for issuance of the revised draft resolution in "blue" form tonight, so that the Council may be in a position to vote on it tomorrow morning.
- 9. Some members of the Council pointed out that they may not have received the necessary instructions from their capitals in the morning. It was, therefore, agreed to hold a last round of informal consultations tomorrow morning in order to finalize the text of the resolution, on the understanding that the Council would then move to a formal meeting to adopt it.
- 10. We are also attaching a letter, dated 20 June, addressed to the Secretary-General by the Permanent Representative of France. This letter was circulated to Council members this afternoom. Regards.



Welcomes also the offer by Member States (S/1994/734) to cooperate with the Secretary-General in order to achieve the objectives of the United Nations in Rwanda through the establishment of a temporary operation under national command and control aimed at contributing, in an impartial way, to the security and protection of displaced persons, refugees and civilians at risk in Rwanda, on the understanding that the costs of implementing the offer will be borne by the Hember States concerned;
- 3. Acting under Chapter VII of the Charter of the United Nations, authorizes the Hember: States cooperating with the Secretary-General to conduct the operation referred to in paragraph 2 above using all necessary means to achieve the humanitarian: objectives set out in subparagraphs 4 (a) and (b) of resolution 925 (1994);
- 4. Decides that the mission of Hember States cooperating with the Secretary-General will be limited to a period of two months following the adoption of the present resolution, unless the Secretary-General determines at an earlier date that the expanded UNAHIR is able to carry out its mandate;
- 5. Commends the offers already made by Member States of troops for the expanded UNAMIR;
- 6. Calls upon all Member States to respond urgently to the Secretary-General's request for resources, including logistical support, in order to enable expanded UNAMIR to fulfil its mandate effectively as soon as possible and requests the Secretary-General to identify and coordinate the supply of the essential equipment required by troops committed to the expanded UNAMIR:

Welcomes, in this respect, the offers already made by Member States of equipment for troop contributors to UNAMIR and <u>calls on</u> other Hembers to offer such support, including the possibility of comprehensive provision of equipment to specific troop contributors, to speed UNAMIR's expanded force deployment;
- 8: Requests Hember States cooperating with the Secretary-General to coordinate closely with UNAMIR and also requests the Secretary-General to set up appropriate mechanisms to this end;

Mr. President

I received instructions this afternoon to convey to the members of the Security Council the request of the Rwandese Patriotic Front, that if the Council plans to approve the proposed French intervention, it should, simultaneously, authorize the withdrawal of the existing contingent of UNAMIR.

The Rwandese Patriotic front is concerned that its personnel may not always be in a position to make a clear distinction between UNAMIR and other foreign forces in the event of an escalation of hostilities. We have, regrettably, come to the conclusion that it is necessary that UNAMIR personnel be withdrawn to safety, at least on a temporary basis.

We wish to assure your Excellency that this request is made in good faith and does not, in anyway, reflect a desire on our part to avoid our responsibility for the safety of United Nations personnel in our territory.

Monsieur le Secrétaire Général,

La situation humanitaire au Rwanda continue à être désastreuse, le cessez-le-feu n'est pas respecté par les parties et les massacres de populations civiles se poursuivent à grande échelle.

Les résolutions 918 et 925 du Conseil de sécurité donnent à la MINUAR le mandat d'intervenir pour faire cesser cette catastrophe humanitaire. La France et le Sénégal souscrivent pleinement aux objectifs et aux méthodes que préconisent ces deux résolutions.

Mais il faudra sans doute encore quelque temps pour que la MINUAR renforcée conformément à ces résolutions puisse être opérationnelle; les comingents que fourniront les Etats, ainsi que leur équipement ne pourront être acheminés et à pied d'ocuvre avant plusieurs semaines. Ce délai risque de coster encore des milliers de vies au Rwanda et de permettre une expansion géographique de la zone touchée par le drame.

Dans ce contexte, les gouvernements français et sénégalais sont disposés à envoyer sur place sans délai une force destinée à assurer la jonction avec l'arrivée de la MINUAR renforcée. Ils: sont en comact avec d'autres Etats membres susceptibles de se joindre à l'opération. Les objectifs assignés à cette force seraient les mêmes que ceux que le Conseil de sécurité a fixés à la MINUAR c'ast-à-dire de contribuer à la sécurité et à la protection des personnes déplacées, des réfugiés et des civils en danger au Rwanda, y compris par la création et le maintien, la où il sera possible, de zones humanitaires sures. Cet objectif est naturellement exclusif de toute intervention dans l'évolution du rapport des forces militaires entre les parties prenantes au conflit.

Dans l'esprit de la résolution 794 (1992) du 3 décembre 1992, nos gouvernements souhaitent disposer, comme cadre juridique de leur intervention, d'une résolution placée sous le chapitre VII de la Charte des Nations Unies leur donnant mandat d'agir jusqu'au déploiement de la MINUAR renforcée. Dans notre esprit, la force intérimaire devrait pouvoir se retirer vers le milieu du mois d'août au plus tard, après avoir passé le relais à la MINUAR, lorsque ses renforts seront déployés.
